

**Agenda Items and List of accepted nominations for
workshop at Allahabad on 20th November 2006**

Session I (10.00 hrs - 11.15 hrs)

The participants have been divided into four groups and each group will have to discuss on the COMPACT Modules as under:

Pension and CPFM

Group II

GPF and Budget Modules

Pre-check and Master Modules

Compilation Module

1. During the course of discussion the group is required to deliberate upon following points:

- a) Main problems associated with the module of the package/ package assigned to the group. The working group would be required to enumerate 7-8 such issues during Session II.
- b) Discuss possible improvements to make the package operationally more useful and effective.
- c) Discuss the issues where the computerized system deviates from existing systems as mandated by manuals/rule books.

2. Groups should preserve the working sheets used (detailing all issues of discussion) and hand them over to their respective coordinators.

Session 2. (11.30 hrs - 12.30 hrs)

Each group will be given 10 minutes for presentation of the findings of the working group with respect to (a), (b) and (c) listed above. One member of the group to present the main findings.

Session 3 (12.30 hrs - 13.00 hrs)

Demonstration of e-Lekha package, e-MIS and hand on practice of e-Lekha uploading.

Session 4. (14.00 hrs - 14.45 hrs)

During the course of open session the participants are requested fully participate in discussions and give their inputs regarding various IT issues;

- a) Ways to develop a better MIS-8 to review COMPACT implementation in a PAO
- b) COMPACT support strategy & feedback mechanism
- c) Possible IT initiatives, which can be taken by the CGA organization for implementation in field units.
- d) Other mechanism for providing support to the implementation of packages in the field units. COMPACT support group is one such initiative.
- e) Training requirements in the Information Technology field.
- f) Any other relevant issues including e-Lekha
