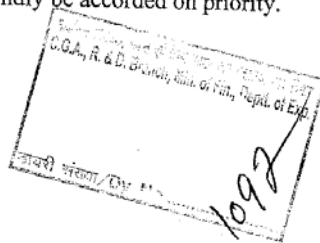

1. 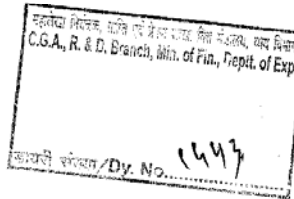
